## Order no. 2032/2019

I — Fundação Millennium BCP, legal person no. 502689943, with registered office at Lisbon, was established by public deed on 27 December 1997 and recognised by Ordinance no. 115/94 published in Diário da República, 2nd series, of 24 of August.

II — Fundação Millennium BCP obtained the status of public utility under Decree-Law no. 460/77 of 7 November, by statement published in Diário da República, 2nd series, of 18 January 1995.

III - The status of public utility given to Fundação Millennium BCP was confirmed under paragraph no. 7 of Article 6 of Law no. 24/2012, of 9 July, by Order no. 2578/2013, of 4 February, published in Diário da República, 2nd series, of 18 February, for a five-year period.

IV - To comply with the provisions of no. 5 of Article 25 of the Framework Law on Foundations, approved by Law no. 24/2012, of 9 July, amended and republished by Law no. 150/2015, of 10 September, Fundação Millennium BCP has come to request the renewal of its status.

V - Verifying that all the legal assumptions and requirements are still met, as set out in the information from DAJD/656/2018 services, which received the agreement of the Head of the Legal Services and Documentation and of the Deputy General Secretary of the Presidency of the Council of Ministers, as well as in the documentation contained in administrative process no. 7/VER/2018, instructed in the Deputy General Secretary Office of the Presidency of the Council of Ministers, in the use of the powers delegated to me by the Prime Minister through Order no. 3440/2016, of 25 February, published in Diário da República, 2nd series, of 8 March, I renew the status of public utility of Fundação Millennium BCP, under the terms of no. 5 of article 25 of the Framework Law on Foundations, approved by Law no. 24/2012, of 9 July, amended and republished by Law no. 150/2015, of 10 September

VI - The renewal is valid for five years from the publication of this order, taking effect from 18 February 2018."
