## Order no. 9249/2023

Summary: Renews the status of public utility of Millennium bcp Foundation.

## **Renewal of Public Utility Status**

Millennium bcp Foundation, private legal person no. 502689943, of foundational type, non-profit and with registered office at Lisbon, has been carrying out activities of general and local interest in history, art and culture, teaching and scientific research and dissemination since it was established in 1994. It was granted a declaration of public utility under Decree-Law 460/77 of 7 November by order of the Prime Minister on 29 December 1994, published in Diário da República, 2<sup>nd</sup> Series, no. 15, of 18 January 1995. Public utility status was confirmed under Article 6(7) of Law 24/2012, of 9 July, by Decision 2578/2013 of the Secretary of State for the Presidency of the Council of Ministers, of 4 February 2013, published in Diário da República, 2<sup>nd</sup> Series, No. 34, for a period of five years, and was renewed, under the terms of paragraph 5 of article 25 of the Framework Law on Foundations, by Decision no. 2032/2019, of the Minister of the Presidency and Administrative Modernization, of 13 February 2019, published in Diário da República, 2<sup>nd</sup> Series, no. 42, of 28 February 2019, for a period of five years.

In order to comply with the provisions of Article 19(3) of the Framework Law on Public Utility Status, approved in annex to Law 36/2021 of 14 June, it has applied for renewal of the status. Verifying that the necessary assumptions and legal requirements are maintained, as set out in the information from the services no. I/1994/2023/SGPCM, of administrative process no. PROC/1148/2023, instructed at the General Secretariat of the Presidency of the Council of Ministers, and in the use of the powers sub-delegated to me by the Minister for the Presidency through Decision no. 7937/2022, of 23 June, published in Diário da República, 2<sup>nd</sup> Series, no. 124, of 29 June 2022, I renew the public utility status of Millennium bcp Foundation, under the terms of article 19(1) of the Framework Law on Public Utility Status, for a 10-year period, starting on 28 February 2024.
